# Applications for State COVID Relief Funding Begin August 1

If your nonprofit arts organization saw revenue decreases between 2020 and 2021, you can begin applying for COVID relief funding from the state on August 1.

Earlier this year, the Kentucky legislature allocated \$75 million in relief funding for Kentucky nonprofits impacted by the COVID pandemic. The Public Protection Cabinet, which will administer the Team Kentucky Nonprofit Assistance Fund, recently announced program guidelines and the location of the online application portal <a href="teamkynonprofitfund.ky.gov">teamkynonprofitfund.ky.gov</a>.

Arts organizations are eligible if they are registered with the IRS as a 501(c) 3 organization (nonprofit) and if they have a physical location in Kentucky and serve Kentuckians. The program will fund an organization for the net revenue difference between calendar year 2020 and 2021 up to \$100,000. If your organization files taxes based on calendar year, you can submit IRS 990 forms to show revenue. Organizations that file on fiscal year must submit profit and loss statements for the years.

Organizations that did not receive previous direct federal aid will be given priority. According to the program's Frequently Asked Questions sheet, Shuttered Venue Operators Grants and Provider Relief Funds administered directly by federal agencies (SBA and HHS) are considered direct aid, but PPP loans and funding received through state or local agencies or entities are not considered direct federal aid.

Even if an organization received previous aid, they should still apply since funds may still be available after applicants who were previously unfunded are processed.

The application portal will open at 9 a.m. ET on August 1 and close at 4:30 pm ET on October 1. While applications of previously funded organizations will be not reviewed until after October 1, the cabinet recommends that all organizations apply as soon as possible since funding will be distributed on a first-come first-served basis. According to the cabinet, organizations may begin receiving funding as early as late August.

## **House Passes Federal Arts Funding**


On July 20, the U.S. House passed the FY '23 Interior Appropriations bill with increased funding of \$207 million each for the NEA and NEH, and full funding for the Smithsonian Institution as part of a 6-bill minibus funding package. All weakening amendments, including the ones offered by Congressman Glenn Grothman (R-WI) attempting to cut arts funding, were defeated "en bloc" by a vote of 230 no's to 197 aye's. Ky. Rep. John Yarmuth was one of those voting down the amendments; Ky.'s other representatives voted for the weakening amendments. The bill now goes to the Senate Appropriations Committee. Americans for the Arts' Arts Action Center has an online form through which you can encourage Sen. McConnell and Sen. Paul to support matching the House-approved FY '23 funding levels for the NEA and NEH at \$207 million each.

"I feel very lucky that Kentucky will be my home base for this," Limon told *Southern Living*. "Because I think it's important to remember that the literary legacy of the United States is not just bicoastal. The United States has a rich history of literary accomplishment throughout each state, and I'm proud to represent Kentucky in that way."

#### **Teddy Abrams Named Conductor of the Year**

Musical America recently named Teddy Abrams, Music Director of the Louisville Orchestra, as 2022 Conductor of the Year. Abrams is in his eighth year in Louisville and was lauded for building the connection between the orchestra and the community.
