# Find Out More About ARPA Funding at New KNN Resource Web Page

The American Rescue Plan Act (ARPA) provides over \$3.77 billion for Kentucky, including \$867.8 million in funding for Kentucky counties and \$931 million for Kentucky cities.

With decisions being made at both local and state levels, this is the time to voice your support for key investments in the arts. In fact, your voice is critical. Many officials may not be aware that partnering with nonprofits is an EXPECTED use of ARPA funds.

Check out the new Funding Opportunities resource at the KFTA website. Upcoming opportunities include emergency funding for professional dancers; six grants for art museums; and funding for arts collaborations that serve military and veteran families. KFTA will continue to add to this listing as new state and national funding opportunities are announced.

### Groundbreaking National Arts Education for All Act Introduced

On Oct. 15, U.S. Rep. Suzanne Bonamici (D-OR), Rep. Chellie Pingree (D-ME), and Rep. Teresa Leger Fernández (D-NM) introduced comprehensive legislation in the U.S. to increase access to arts education. It is the first federal level legislation specifically addressing arts education, and while it includes no funding, it would expand the offering of arts education and programming experiences to Americans including our youngest learners, K-12 students, and youth impacted by the juvenile justice system.

What would the bill do?

- Strengthen the ability to use Child Care Development Block grant funding for arts programing.
- Expand Elementary and Secondary Education Act (ESEA)
  plan provisions to include descriptions of how states would
  support and encourage the offering of arts education staff,
  instruction and partnership to improve student achievement in
  all subjects.
- Require State ESSA report cards to include information on arts courses to be included and infuses arts education as an element of K-12 school improvement.
- Increase opportunities for local education agency support for professional development for arts teachers and integration of the arts.
- Strengthen the integration of arts and arts education through the 21st Century Community Centers after school program.
- Provide for states to document how they will coordinate services and activities for juvenile justice and delinquency prevention with state and local arts organizations by utilizing arts education to improve reentry efforts and to reduce recidivism.
- Enhance research activities at the Institution for Education Sciences through a focus on arts and arts ed research.
- Direct the National Assessment Governing Board to reinstate national arts assessments.
